## Seminar

- Content of the Seminar is based on the topics contained in her book - "The Dog Driven Search"
- If you choose to only audit one day, it must be Saturday based on flow of material Dana will be presenting.
- There will be 10 Working spots per day. Participants will be selected by Dana Zinn and Host after review of teams back ground and experience. A working spot consists of working 1 day and auditing the other. To be considered for a working spot you must agree to attend as an auditor both days if not selected.
- Selection will be based on skill sets of various teams, working styles of various breeds and problems areas that match team requests -- the goal is select teams that will best illustrate the content that Dana will be covering. Selection process will begin on April 1<sup>st</sup>.
- A deposit of \$125 is required to be considered for a working spot = balance will be due May 1<sup>st</sup>. Balance for working is \$200 and for non working \$125.
